## Co-ops & Our Structure: a report-back by Noah, with notes from Tim

Last month, Tim & I met with a lawyer named Thomas Beckett. He lives in Hendersonville, NC and has been working with cooperatives on legal questions for many years. This meeting is part of the conversations the Bread Team has been having about moving Bread Uprising to a cooperative legal structure. Important takeaways from the meeting (see below for more detail):

1. LLCs are probably the best option for us.

2. We need to make sure we prioritize the things that are important to us (like living wage) in our structure.

#### Some options for structure:

- Corporation: grew out of British law (East India Tea Company) as a technique for assembling large amounts of capital. Major benefit is that owners/ investors are not liable if something goes wrong. Rigid structure: have to have a board of directors. Purpose is to make money/profit.
- LLC (Limited Liability Corporation): Owners don't have libability (same as corporation) but has more flexible governance structure. In addition, purpose of LLC is set by members. The only issue is there's not an easy template for creating a cooperative LLC – this is in the works though.

- Partnership: this is our current legal form. Problem is that every member/owner would have to be added as a partner (very cumbersome) and all member/owners would have to take on liability.
- NC does not have a "cooperative association" legal form. Purpose is to meet the needs of members.
- "Policy governance" model: a board (or other governing body) sets policy but workers or managers do day-to-day work. (Seems similar to what we have now – Bread Team visions, bakers have autonomy within that over day-to-day work). Governing body would include both "workers" and "consumers".

### Key questions to create a co-operative legal structure:

- 1. What is this "business"? What is the purpose of this "business"?
- What are the boundaries of ownership how does someone become a member/owner?
- How do owners govern the "business" (governance = guiding the overall strategy/purpose)?

### Money, assets, and resources - some suggestions:

Cooperative model is about building community resilience and wealth – it is generative rather than

- extractive.
- Importance of worker/member/owner buy-in being significant – so that it's a psychological investment. Also shifting to a cooperative mentality from an individualistic one.
- Make sure the money is working out: cooperatives from the 70s that didn't watch their bottomline didn't survive. Those that did were able to continue with their mission.
- Need transparent process for managing cash.
- Wages/pay need to be a top priority if we say we want a living wage, need to plan for that and not just leave to to see if there is money "left over". "Working capital" also important try to keep 6 months of expenses in bank.
